



A lovely copy of a collection of Momaday's poems, which draw on a rich set of traditions and influences unique to Native American poetry. \$200





A Very Good copy with a tiny spot of insect damage to the errata slip and two contemporary owner's markings. Riccardi 386. Wikipedia, "Giovanni Francesco Crivelli". Crivelli was an important mathematician and scientist. He was elected a Fellow of the Royal Society in 1734. His *Elements of Arithmetic* is notoriously difficult to find.


As of 2/19/21 OCLC shows nine holdings worldwide of this title. After this publication, Crivelli completed a work on physics, some of which is still used in high school classrooms today. He was a circumspect scientist, fully aware of the scope of Newton and Galileo's achievements. Crivelli also credited Arabic astronomers in his second publication for their contributions to science and the scientific method. Crivelli's *Elements* focuses heavily on fractions, division, radical numbers, squaring numbers, and elements of algebra. A presentable copy of this scarce arithmetic. **\$500**

Ayer's third book, an exploration of the philosophy of metaphysics and epistemology. He discusses problems like the nature of the reality of the external world, how sense data relates to material things, causality, and how an individual can have knowledge of other minds. Ayer was an important figure in the movement of Logical Positivism, and a significant analytic philosopher. His contributions to epistemology and metaphysics remain critical in the literature of analytic philosophy. **\$600**

In this, his best-known book, he explores foundational questions like what gives a law its proper authority, how legal obligation relates to moral obligation, to what extent laws are made up of social "rules", how justice differs from morality, etc. Hart develops a new analysis of legal validity, sovereignty, legal positivism, and natural law. An attractive copy of this extraordinarily influential book, a cornerstone work in legal philosophy. \$1,500











Shaw's book vividly illustrates the look of the Middle Ages, depicting the costumes and customs of noblemen, women, and the clergy during the Medieval Period. He was a lifelong antiquarian and illustrator, making a living by selling hand-illustrated facsimiles of medieval illuminated manuscripts. His publications fed a Victorian fascination with early European history and archaeology. Here his color plates practically jump off the page, while educating the reader about golden chalices, royal genealogy, jousting and dueling, notable ladies of the period (including Catherine of Aragon), and the founding of the British Monarchy, beginning with King Alfred. One of the best made books of the nineteenth-century, by the inestimable press of William Pickering. \$2,000





Cunningham, "Gillies, John, (1747–1836)". Moss contains a review from 1798 that praises this translation for its elegance and its skill in impressing upon the reader the most important facets of Aristotle's political and ethical philosophy. The review calls it "important reading" for the "enlightened statesman". Dr. John Gillies was a British classicist of the eighteenth century who translated Isocrates, Lysias, and of course, Aristotle. Primarily a historian, Gillies' work focused on the great figures of the ancient world. He was interested in how Greece and Rome shaped (what was then) modern society, and in the interactions between those who lived in Greece and Rome and those whose lands were colonized by these empires. An attractive and impressive set of two of Aristotle's classic philosophical works. \$1,750





A de luxe edition of Plato's four dialogues: Euthyphro, Apology, Crito, and Phaedo. William Whewell's translation, originally published at Cambridge in 1860. Bernard Suzanne, "Plato and His Dialogues". This volume contains an antiquated grouping of four of Plato's dialogues. The four here are grouped according to conventions of Greek Tragedy (as argued by Diogenes Laertius and Thrasyllus). Euthyphro, Apology, and Crito all relate to the laws driving the trial and execution of Socrates, as well as reporting Socrates' last days alive. Phaedo's subject matter is lighter: it centers on a discussion of the destiny of the human soul after death. Thus, the grouping has the three tragic works and one "comedic" work, a Greek dramatic tetraology. A beautiful volume, containing one of the most moving stories in philosophical history. \$625




A Very Good copy with a tiny chip to the foot of the spine and a touch of rubbing to the boards' corners. Leaves remarkably clean. Oxford Classical Dictionary, "Horace", 724-76. Horace's body of work ranges from comedic to philosophical, rendering him one of Rome's most appreciable but weighty literary figures. He writes about his experiences at the Battles of Philippi and Actium, fighting in Brutus' army. He was lucky to retain his land after being on the losing side of the Roman Civil War. His writings helped him make sense of the violence he witnessed during the war. His letters, a later work, reflect on aging and the best way to lead one's life. The Ars Poetica is Horace's treatise on writing an elegant, well -crafted poem. An instructive text from a master of the form. A lovely edition of several of Horace's most significant works, well-made by the renowned Foulis Press. \$500




Oxford DNB, Gillian Thomas, "Weston, Jessie Laidlay (1850–1928)". Wikipedia, "Sir Gawain and the Green Knight". This is the first Modern English translation of *Sir Gawain and the Green Knight*, done after the poem was published in its original Middle English from the manuscript in 1839. A story not represented in Mallory's *Morte D'Arthur*, Sir Gawain and the Green Knight combines themes of homosocial relationships, chivalry and honor, and gender dynamics in one short but powerful poem. Gawain's beheading game with the Green Knight reveals the power of men and women in Arthurian England, and how far they would go to test each other's resolve. **\$400**




Pliny the Younger was a soldier and a senator in the latter part of the first century A.C.E. into the second century A.C.E. During his lifetime he wrote and published nine books of literary letters, concerned with social, domestic, judicial, and political matters. These letters are rhetorically crafted with their syntax and semantics tooled to create a new literary style (new to Rome). His letters provide a history of quotidian matters in Rome, with plenty of anonymous criticisms (aimed at slave owners, political weasels, and the miserly). Senatorial debates, elections and trials, and other matters of public life are revealed in his letters. The final book is composed of letters between him and Trajan. These were likely first published after Pliny's death. These letters function as a historical source for understanding how the Romans governed their provinces. In one letter, Pliny describes one of the earliest accounts of Christian worship, and describes the prejudiced attitude of pagan people towards (what was then) the Christian minority in the Roman Empire. An illuminating history of Rome, beautifully bound. \$750









The first Lippincott edition was published in 1864, the true first edition of this work was published in 1853-54. A nice set of Jefferson's letters and autobiographical writings. His correspondences with John Adams, James Monroe, Alexander Hamilton, George Washington, and other American Revolutionaries are included. In his letters and writings, Jefferson discusses U.S. Political Procedure (including his manual for Senate Parliamentary Procedure), the Thirteen Colonies, The Louisiana Purchase, his diplomatic missions in Europe, and his farm and estate. A thorough portrait of Thomas Jefferson's life and times, written in his own hand. \$650










Wikipedia, "Mohini M. Chatterji". Chatterji was a Bengali attorney and scholar and a member of the Theosophical Society. This is the first edition of his translation of *The Bhagavad Gîtâ*. Chatterji's work often focused on analyzing the commonalities between Hindu and Christian literature. A nice English translation of the Gîtâ, difficult to find in collectible condition. **\$200**

A literary biography providing a captivating narrative of the life of Friedrich Nietzsche. O'Brien's biography begins by telling the story of Nietzsche's difficult childhood and how it formed his adult personality. The author also focuses heavily on the love story between Nietzsche and Cosima Wagner, and its tragic ending. O'Brien aims to show how the philosopher's personal life shaped his work, and thus the course of Continental philosophy. \$175



John Venn was influenced by De Morgan, George Boole, and John Stuart Mill (all accomplished logicians). He pioneered the frequency theory of probability in this publication, in which "assertions of probability are understood as purely empirically based judgements on the recurrence of types of events over time, independent of an observer's feelings". Venn advised his reader to favour skepticism over belief.

His analysis of the wide variety of uses of the term "probability" was original, with his argument that the theory of probability had


uses for a limited portion of human actions. Venn's application of this argument to the moral sciences was an important contribution to the field of statistical and philosophical research. He was the first to craft the Venn diagram, a key tool in testing propositions and syllogisms, representing sets, and unions and intersections between multiple sets. These diagrams are still of course in use today in mathematics and in numerous other fields. An influence for J.M. Keynes and for other mathematicians, Venn's work and legacy helped galvanize the next generation of Cambridge-trained mathematicians. **\$250**



His editorial work on Twain's notebooks in this volume was one of his last major literary publications, completed just two years before he died. 






She converted a girls' high school into a college for Turkish women during her lifetime (Constantinople Women's College). Mills Patrick herself was exceptionally educated, earning her Master's degree from the University of Iowa in 1890. She received a Ph.D. from the University of Bern in Switzerland in 1897. Her dissertation was called Sextus Empiricus and Greek Scepticism and was published in 1899. During her work in Turkey and Armenia, Mills Patrick learned ancient and modern Armenian, Turkish, and modern Greek. In this volume she showcases the ancient beauty of the Greek islands and how it has endured into the modern era. The second half of the book provides a biography of Sappho, an analysis of her impact on modern literature, and a translation of some of Sappho's surviving poetical fragments.
